Each day of the Truckee Pro Rodeo will feature Mutton Bustin'. It is open to any child between the ages of 4 and 8 years old and weighing 50 pounds or less. Each day will be limited to 13 entries and participants will be admitted for only one ride. Each Mutton Bustin' contestant will receive a commemorative t-shirt, a general admission ticket for the child and a parent/guardian to the rodeo on the day the child rides. A prize will be awarded for each performance to the first place Mutton Buster. **Helmets will be provided! Vests are not required**

Once we receive your application and payment, our Mutton Bustin Coordinator will contact you to confirm receipt and your designated ride day. Incomplete applications will not be processed. Applications will be accepted through July 25, 2019. Please allow us two weeks to process your application.

If you are approved you will pick up your child's contestant packet and ride information from the Information Booth at the front of the rodeo grounds on the day your child rides.
